## Consent to participation and to the processing of personal data in the context of a school internship

<b>Information on the processing of personal data in context of a school internship</b>

3. Purposes for which personal data are to be processed	The personal data of internship participants is used exclusively for the purpose of organizing, carrying out, supervising and documenting the internship. This includes the allocation of internship places, communication with the students and their legal guardians, as well as the fulfillment of legal requirements in connection with the internship. An emergency number (not identical to the contact number of the internship participants) is processed by WILO SE for the purpose of accessibility in emergencies.
4. Legal basis for data processing	The processing of the personal data of internship participants is necessary on the one hand for the performance of a contract or for the implementation of pre-contractual measures pursuant to Art. 6 para. 1 sentence 1 lit. b GDPR, and on the other hand the processing of the emergency number is based on consent pursuant to Art. 6 para. 1 sentence 1 lit. a GDPR
5. Recipients / categories of recipients	The data will remain exclusively with WILO SE and will not be passed on to third parties.
6. Transfer to a third country	There is no transfer to a third country.
7. Duration of storage	The data will be deleted as soon as the purpose for which it was collected no longer applies, i.e. within two years at the latest.
8. Rights of the data subject	As a data subject, you have the following rights under the GDPR: <ul style="list-style-type: none"><li>• Access (Art. 15)</li><li>• Rectification (Art. 16)</li><li>• Erasure (Art. 17)</li><li>• Restriction of processing (Art. 18)</li><li>• Objection (Art. 21)</li><li>• Data portability (Art. 20)</li></ul>
9. Right to withdraw consent	You can withdraw your consent at any time with effect for the future at <a href="mailto:hr.youngprofessionals@wilo.com">hr.youngprofessionals@wilo.com</a> .
10. Right to lodge a complaint with a supervisory authority	In addition, there is a right to lodge a complaint with a supervisory authority (Article 77 GDPR in conjunction with § 19 BDSG).
11. Provision of personal data mandatory or necessary	The provision of personal data is necessary in order to be able to carry out the internship. An internship at WILO SE is not possible without providing the data.
