It operates in non-immersed mode with S2-30min capability, allowing for high switching volumes that help reduce required tank sizes. Additionally, Wilo offers customer-specific adaptations such as customized cable lengths and optional PTC sensors for use with frequency converters and soft-start systems, ensuring the pump can be precisely tailored to project needs.
